

**ANNOUNCEMENT REGARDING THE AUTHORIZATION OF MANAGEMENT ON MERTER**

**May 14, 2018** - The decision of suspending the brewing operations located in Istanbul, Merter as of May 22, 2017, in the framework of our environmental, economic, social sustainability strategy and production efficiency program and transferring these operations to our other facilities in Adana, Ankara and İzmir was shared with the public on April 20, 2017.

The Board of Directors has convened to authorize the company management to conduct transactions including, but not limited to, the valuation studies by real estate agencies related to the sale of the 120.657 sqm. property registered in Bahçelievler province of Istanbul with assigned parcel numbers of 23 and 24.

As of 31.12.2017, the property subject to valuation has a net book value of TL 15.4 million and has a 0.6% share within “property, plant and equipment” under Non-Current Assets, and 0.05% share in total assets.

Further developments will be duly announced.
