

**ANNOUNCEMENT REGARDING THE COMPLETION OF THE ACQUISITION OF
60% OF TARIS UZUM**

July 30, 2026 – As announced in our public disclosure dated April 2, 2026, a Share Purchase Agreement (the "Agreement") was signed between our 50.1% subsidiary, AE Mercan Distile İçecekler Pazarlama A.Ş. ("AE Mercan") (formerly operating under the corporate name of Anadolu Etap Dış Ticaret A.Ş.) and S.S. Tariş Üzüm Tarım Satış Kooperatif Birliği for the acquisition of 60% of the shares representing the capital of Tariş Üzüm Alkollü Alkolsüz İçkiler Sanayi ve Ticaret Anonim Şirketi ("Tariş Üzüm"), for a projected amount of USD 26 million (the "Transaction").

In accordance with the terms of the Agreement, the purchase price for the Transaction, which is to be paid by AE Mercan, has been determined as USD 25.4 million following adjustments for working capital and financial indebtedness based on Tariş Üzüm's balance sheet as of the closing date. The approval of the Ministry of Agriculture and Forestry was received and all other conditions precedent set forth in the Agreement were fulfilled. Therefore, the transfer of the shares representing 60% of Tariş Üzüm's share capital to AE Mercan was completed on July 30, 2026 (today).
